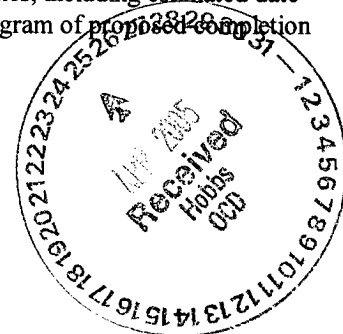

4/13/05: MI x RU. Spud 12-1/4" hole at 7:30 p.m. (NMOCD notified)

4/14/05 -

4/15/05: Run 36 jts. 8-5/8", 24#, J-55, ST&C casing with 10 centralizers and set at 1547'.
RU Halliburton x cement with 500 sx. PBCZ lead and 300 sx. Premium Plus tail.
Displace with 93.5 bbls brine x circulate 213 sx. cement to surface. WOC 4 hours.
Cut off casing x weld on wellhead. NU BOPs. Test blind rams and casing to 1100 psi.
Test pipe rams, annular, and choke manifold to 1100 psi. Drill out cement and
resume drilling operations.
