Dry hole marker should read 1980' FNL and 1980' FWL not 1980' FSL and 1980' FWL. Wellhead, flowline, well sign, conduit sticking out of ground east of marker and power poles (3) and lines on west side of location should be removed. 1ST NOTICE.

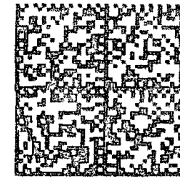
