Above-ground steel tanks will be used for the management of all workover fluids. At the completion of workover operations and removal of all equipment, the area will be secured and prepared for production/injection operations.

II. Operating and Maintenance Plan – based the appropriate requirements of 9.15.17.12 NMAC

Resaca Operating Company will operate and maintain all above-ground steel tanks and bins in workover operations in a prudent manner to prevent any leaks/spills.

Closure Plan – based upon the appropriate requirements of Subsection C of 19.15.17.9 NMAC and 19.15.17.13 NMAC

As stated in the attached design and operating and maintenance plans, the proposed closed loop system is self-contained. No temporary, permanent in-ground pits of any type or drying pads will be used; therefore there is no on-site closure. All solids will be contained, transported to an appropriate disposal site and disposed of. All fluids will be collected from the closed loop system and disposed of at an appropriate disposal site or moved to the next site for further service. All closed loop system equipment will be removed from the drill site.
