Re-contour the old well pad from past reclamation in order to allow the natural flow of water. Return the contour of the landscape back to it's original form as best possible to allow the run-off water to flow with the natural order of flow through the area. The north-west corner section of the pad will be moved south towards the middle more as to allow the flow of water to run naturally to it's path. The South section will be built up even further to build up over the old pit. This too will also allow the flow of water on the south section to run its natural course as well. All work being done as per discussions between Oxy and BLM personnel.
