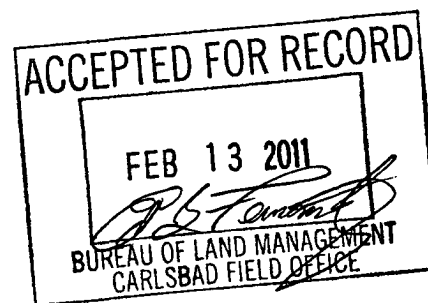

- 3.) PU Swivel; Drill and clean out to TD @ 3535', circulate well clean.
- 4.) POOH w/ tubing; LD drill collars & bit.
- 5.) Hydrotest tubing; RIH w/ production string.
- 6.) RDMO Pulling Unit, clean location, clean and dispose of pit fluids.
