SHUT IN NOTICE

The Sinagua 18 Federal 002 has been shut in since 2/24/2012 due to no electricity. LINN filed for a ROW with BLM to build an electrical line on 3/26/2012. Per Wesley Ingram, LINN was advised that a subsequent sundry needed to be filed to explain why the well was shut in and that the ROW has yet to be approved by the BLM. LINN has received a ROW back from the BLM for final execution and payment and LINN plans to return the ROW back to the BLM this week in order to gain final approval to the build the electrical line. Additionally, after LINN receives approval, the electrical line should be built within a couple of weeks.

or plans to P & A must be submitted.
