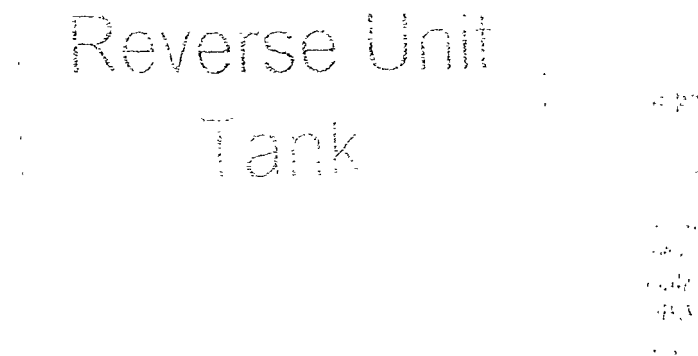

Operation and Maintenance Plan

1. All recovered fluids and solids will be discharged into reverse tank.
2. Reverse tank will be continuously monitored by designating reverse tank technician or overfilled.
3. Pig crew will visually inspect fluid integrity of reverse tank and frac tanks on a daily basis.
4. Documentation or visual inspection of reverse tank and frac tanks will be captured on daily completion morning report.

Closing Plan

1. All recovered fluids and solids will be removed from reverse tank and hauled off of site.
2. All recovered fluids and solids will be disposed of at a suitable off location waste disposal facility.
3. Any remaining frac fluids in frac tanks will be hauled off location.
