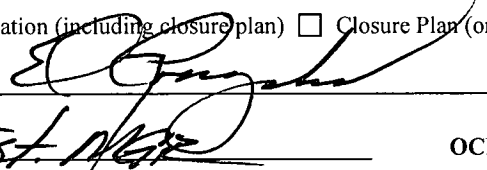

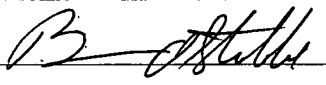

- 2 - G-M Haul-off bins with track system
- 1 – 500 BBL frac tank for fresh water
- 1 – 400 BBL open top tank for liquid waste

Operations and Maintenance:
