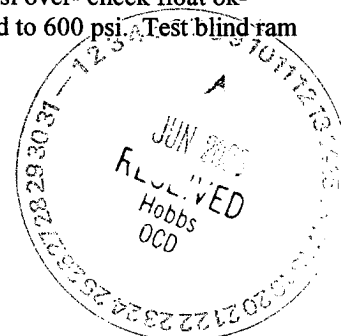

Displace w/73.8 bbl brine - Landed plug w/500 psi over- check float ok- Circulate 130 sx to pit. Cut off conductor \* 8-5/8" casing- weld on 8-5/8" SOW x 3M WP casinghead to 600 psi. Test blind ram and choke manifold to 1000 psi.
