7/10/12: NU BOP, choke, RU gas buster. Test pipe rams, blind rams, all valves & chokes to 3000psi, 250psi low, test hydr to 1500psi, tested all BOP accessories, kelly valve, floor safety valve. Spoke to Paul Flowers w/BLM before tests.

7/18/12: TD 7 7/8" hole.

7/19/12: Run 195 jts 5 1/2" L-80 LTC 17# esg @ 8072'. RU O-Tex pumping. Pump 200 bbl of OS-30, 24 bbl of Sure Bond, 20 bbl fresh water sp. & cmt w/600 sks of 11.8# 2.45 yld, 13.78 gp/sx 50:50 class H lead & 800 sks of 14.4#, 1.31 yld 5.48 gp/sx, 50:50 class H tail. Disp w/186 bbl of 2% KCL. ND BOP, set slips w/125K & install tbg head & clean pits. Run temp survey for TOC @ 1691'. Rlse rig @ 19:00
