Intermediate string will be cemented in two stages with a DV tool at approx. 3325'

Stage 1: Lead - 180sx of 35:65:6 PozC (YLD 2.0 WT 12.5), Tail - 200sx of Class C (YLD 1.34 WT 14.8) 4350'-3325'

Stage 2: Lead - 910sx of 35:65:6 PozC (YLD 2.0 WT 12.5), Tail - 200sx of Class C (YLD 1.34 WT 14.8) 3325'-0'

Cement designed with 100% excess

The minimum required fill of cement behind the 9-5/8 inch intermediate casing is

a. First stage to DV tool. Cement to circulate. If cement does not circulate, contact the appropriate BLM office before proceeding with second stage cement job. Operator should have plans as to how they will achieve circulation on the next stage.

b. Second stage above DV tool. Cement to surface. If cement does not circulate, contact the appropriate BLM office.
