NOTE:

3. Operations and maintenance stops the tank for daily operations as well as emergency.

Start-Up and Shut-Down Plan:

1. All recovered fluids and solids will be discharged into reverse tank.
2. Reverse tank will be automatically initiated by designated signal and the tank will not be overfilled.
3. Rig crew will visually inspect fluid integrity of reverse tank and front tank periodically.
4. Decommissioning unit inspection of reverse tank and front tank will be completed every 24 hours or more frequently.

Shutdown Plan:

1. All recovered fluids and solids will be removed from reverse tank and transferred to shore.
2. All recovered fluids and solids will be disposed via a suitable off shore waste management facility.
3. All remaining fluid and solids will be removed from
