Notes:

1. This is a generic layout, exact equipment or elevation will vary from location to location. This is a schematic representation, so drawing is not to scale.
 2. Free tanks and number of pumps can vary, with daily operations and well requirements.
- ### Operation and Maintenance Plan
1. All recovered fluids and solids will be discharged into reverse tank.
 2. Reverse tank will be continuously monitored by designated rig crew so that tank will not overfill.
 3. Rig crew will visually inspect fluid integrity of reverse tank and free tanks on a daily basis.
 4. Documentation of visual inspection of reverse tank and free tanks will be captured on daily completion monitoring report.
- ### Spill Response Plan
1. All recovered fluids and solids will be removed from reverse tank and returned off site.
 2. All recovered fluids and solids will be disposed of at a suitable off bore or waste disposal facility.
 3. Any remaining free fluids in free tanks will be moved off location.
