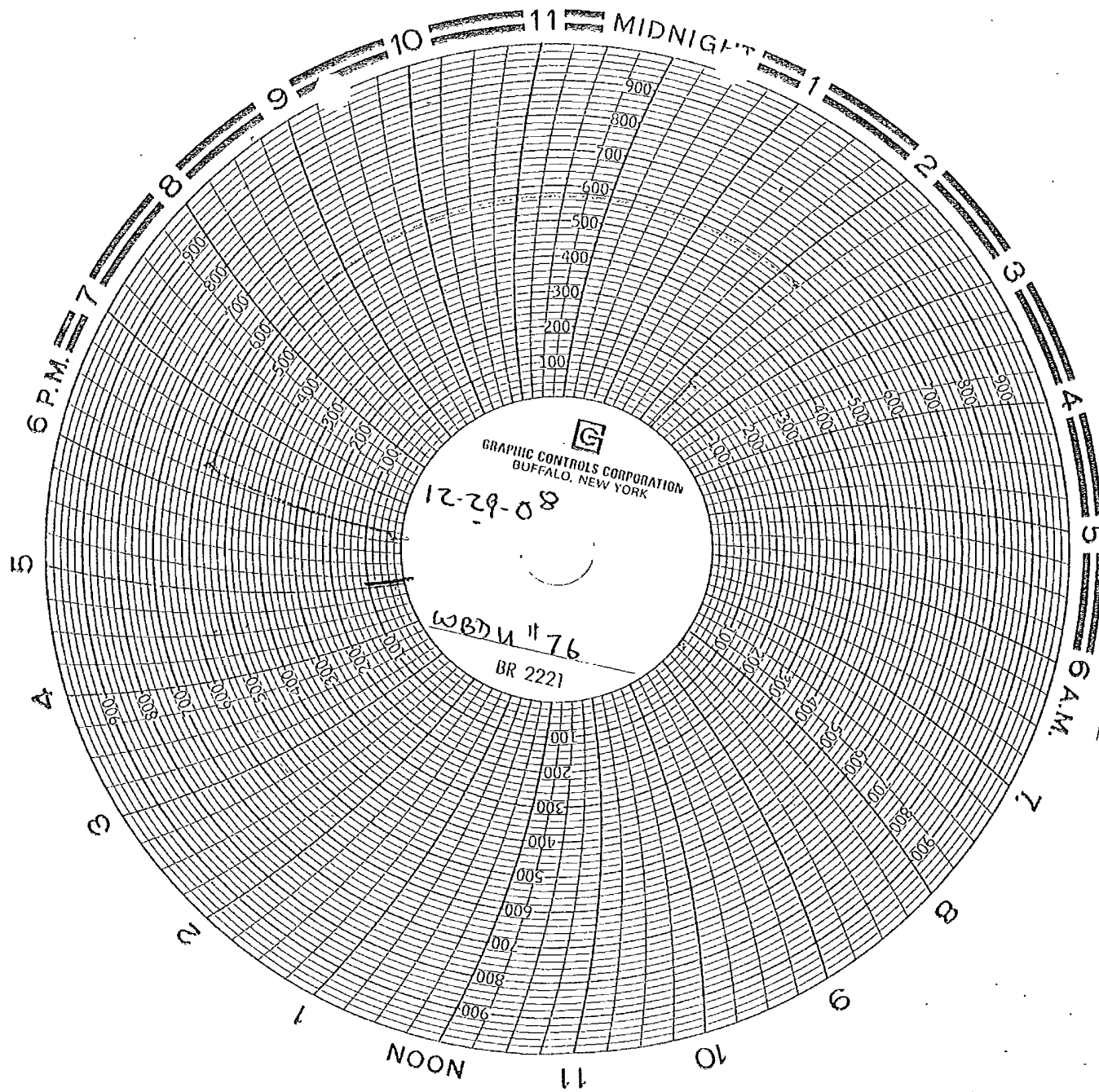

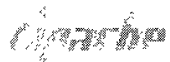


Apache's production accounting department emailed me that there was a well converted to injection back in 2008 which she couldn't find paperwork for – WBDU #76. I researched and found that for whatever reason, the NOI was the last thing filed on this well since 2008?!? ☹ I then filed the conversion paperwork to Miss Donna. As you'll see at the bottom of this e-mail, she notified me that she needed the chart. Well . . . after checking with my Foreman, the only thing we have in the file is the pre-chart we ran to make sure it tested (see copy attached), and the original MIT chart was taken at the time when the well was tested and witnessed, so we don't even have a copy. (another sad face) ☹ The field guys went to check the well yesterday before notifying

Mark Whitaker to come witness and the well is down. They shut the well in immediately and will keep it that way until our Engineer can figure out what needs to be done and get an AFE circulating.

Is approval of the paperwork I sent Donna possible based on just this chart?!?! I'm guessing she has no record of the official one taken in 2008, since she asked me for one? I can get the original pre-chart from my Foreman if this copy won't work.


