1. This is a schematic of the equipment original to all vessels and is not to be altered.
2. This is a schematic of the equipment and drawing is not to scale.
3. Free tanks and number of pumps may vary with daily operations and well equipment.

Operating and Maintenance Plan

1. All recovered fluids and solids will be discharged into reverse tank.
2. Reverse tank will be continuously monitored for design capacity so that it does not become overfilled.
3. Rig crew will maintain the structural integrity of reverse tank and free tank on a daily basis.
4. Documentation of visual inspection of reverse tank and free tanks will be conducted on daily basis when working on well.

Close Up Plan

1. All recovered fluids and solids will be removed from reverse tank and transferred off vessel.
2. All recovered fluids and solids will be disposed of in a suitable off location or be reused on future.
3. Any equipment or free tanks will be transferred off location.
