Reverse Unit Tank

Notes:

1. This is a generic layout of the equipment and the location will vary from location to location.
2. This is a schematic representation, so drawing is not to scale.
3. Fluid tanks and skimmer or pumps can vary with daily operations and fluid requirements.

Operation and Maintenance Plan:

1. All recovered fluids and solids will be discharged into reverse tank.
2. Reverse tank will be continuously monitored by designated personnel or will be overfilled.
3. Rig crew will visually inspect fluid integrity of reverse tank and fluid tanks on a daily basis.
4. Documentation of visual inspection of reverse tank and fluid tanks will be captured on daily completion summary report.

Spill Response Plan:

1. All recovered fluids and solids will be removed from reverse tank and hauled off site.
2. All recovered fluids and solids will be disposed of in a suitable off shore or on shore disposal facility.
3. Any remaining fluids in fluid tank will be hauled off location.
