Equipment & Design:

Wagner Oil Company will use a closed loop system in the plug and abandonment of this well. The following equipment will be on location:

(1) 250 bbl steel reverse tank

Operations & Maintenance:

During each day of operation, the rig's crew will inspect and closely monitor the fluids contained within the steel tank and visually monitor any release that may occur. Should a release, spill or leak occur, the NMOCD District 1 office Hobbs (575-393-6161) will be notified, as required in NMOCD's rule 19.15.29.8.

Closure:

After plugging operations, fluids and solids will be hauled and disposed at Gandy-Marley Disposal Location, permit number 711-01-0019. Secondary site will be Controlled Recovery, permit number R9166.

Soil Cover:

Remediate soil to consist of the background thickness of topsoil or one foot of suitable material to establish vegetation and to the site's existing grade, preventing ponding of water and erosion of the cover material.

Re-vegetation:

Disturbed area will be revegetated by reseeding during the proper growing season with a seed mixture of natural grasses as recommended by the BLM.

Site Reclamation:

Location will be leveled and contoured to as nearly the original topography as possible.
