Operation: Plug and Abandon

Equipment and Design:

Legacy Reserves Operating, LP will use a closed loop system for the well operation on the subject well. The following equipment will be on location:

- 1) 250 bbl steel tank

Operation and Maintenance:

During each day of operation, the rig crew will inspect and closely monitor the fluids contained within the steel tank and visually monitor any release that could occur. Should a release or spill occur, the NMOCD District 1 office in Hobbs, New Mexico (575-393-6161) will be notified, as required in NMOCD Rule 19.15.29.8.

Closure:

After plugging operations are complete, all well and plugging fluids and solids waste will be hauled and disposed at Sundance Services (permit number NM-01-0003).
