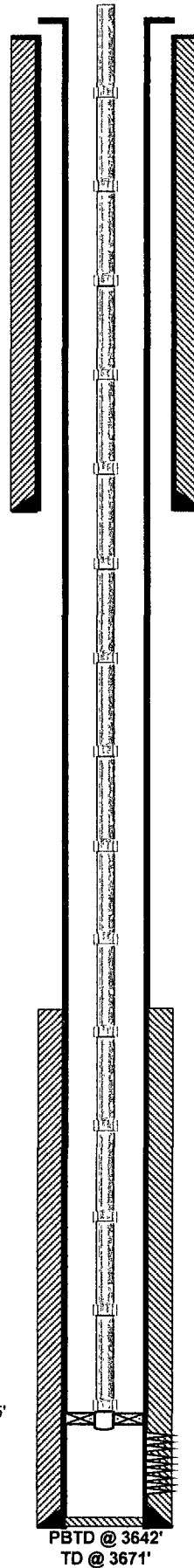

3. PUH & perf @ 2400', RIH w/ tbg to 2600' & spot 40 sx Class "C" cmt, PUH & sqz cmt to 2350' WOC/TAG (Yates & Base of Salt)

2. MIRU P&A rig, RIH w/ tbg & CIRC w/ MLF, & spot 25 sx Class "C" cmt from 3400'-3000' WOC/TAG (CIBP, QN & 7 Rvrs)
