Mixed @ 14.8#/g w 1.34 yd. Plug down @ 4:45 AM 10/25/12. Circ 100 sks cement to pit. WOC 18 hrs. Tested BOPE to 1250#. At 10:30 AM 10/26/12, tested csg to 1250# for 30 mins, held OK. Drilled out with 12 1/4" bit.
