Cemented stage 1 with 1070 sx PVL + 30% CO-31 (yld 1.82, wt 13). Circulated 154 sx to pit. Cemented stage 2 with 430 sx 36:65:6 Poz "C" (yld 2.06, wt 12.6). Tailed in with 180 sx 50/50 Poz "C" (yld 1.37, wt 14.2). NOTE: Notified Jack Johnson with BLM 4 hrs prior to casing operations.
