Stage 1: Lead - 375sx of 35:65:6 PozC (YLD 2 WT 12.5), Tail - 1655sx of PVL (YLD 1.41 WT 13) 8400'-17449'

Stage 2: Lead - 600sx of 35:65:6 PozC (YLD 2 WT 12.5), Tail - 200sx of PVL (YLD 1.41 WT 13) 4090'-8400'

Cement designed at 35% excess.
