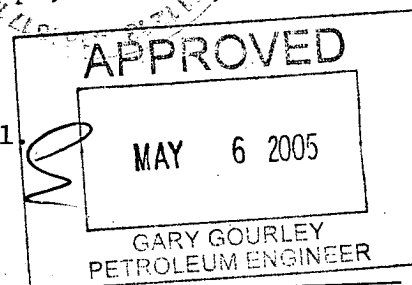

2. Acidize Bone Spring 9281'-9328' w/ 4000 gal 15% acid.
3. Test well.
4. Either put well on production or set CIBP @ 9200' & TA well.
