TIH w/RBP and pkr on workstring. Set RBP @ 4780'; pull up and set pkr @ 4700'.

Acidize perfs 4712' - 58' w/2000 gals 20% HCL NEFE; swb back load.

Retrieve BP and set @ 4650'; pull up to set pkr @ 4560'. Acidize perfs 4584'-4635' w/2000 gals 20%

HCL NEFE; swb back load. TOH w/pkr and BP; run production eqpm.
