3. Set CIBP @ 3175'. Correlate to Neutron/Density log dated 8/17/04.
4. Bail 2 sx of cmt on top of CIBP. Load hole with packer fluid. Pressure test and chart casing to 500 psi.
5. RDMO
6. Submit final sundry w/chart to BLM.
