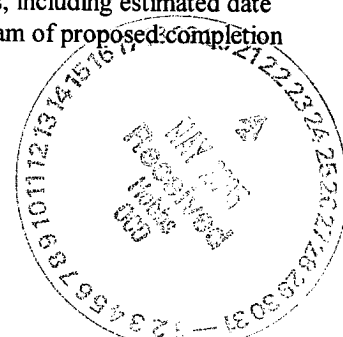

5/15/05: MI x RU. Spud 12-1/4" hole at 7:00 p.m. (NMOCD notified)

5/16/05 -

5/17/05: Run 36 jts. 8-5/8", 24#, J-55, ST&C casing with 10 centralizers and set at 1471'.
RU Halliburton x cement with 450 sx. PBCZ lead and 300 sx. Premium Plus tail.
Displace with 10 bbls FW x 83.5 bbls brine and circulate 42 sx. cement to surface.
WOC 4 hrs. Cut off casing x weld on wellhead. NU BOPs. Test blind rams and casing
to 1500 psi. Test pipe rams, annular, and choke manifold to 1500 psi. Drill out
cement and resume drilling operations.
