4/22/05 - Resumed drilling at 6:30 AM.

4/23/05 - Set 13-3/8" 48# H-40 ST&C casing at 425'. Cemented with 240 sx "C" + 2% CaCl + 1/4# SF (yld 1.35, wt 14.8). Tailed in with 200 sx "C" + 2% CaCl (yld 1.34, wt 14.8). Cement circulated to surface. WOC. Tested casing to 600 psi for 30 min. WOC 35 hrs 9 min. Reduced hole to 12-1/4" and resumed drilling.

5/1/05 - Set 9-5/8" 36# & 40# J-55 ST&C casing at 3700'. Cemented with 1290 sx 35:65 Poz "H" + 5% Salt + 1/4# Celloflake + 6% Gel (yld 2.04, wt 12.5). Tailed in with 200 sx "C" (yld 1.34, wt 14.8). Cement circulated to surface. WOC. Tested casing to 1500 psi for 30 min. WOC 43 hrs. Reduced hole to 8-3/4" and resumed drilling.
