As required by 43 CFR 3162.7-2 and Onshore Oil and Gas Order No. 4, ChevronTexaco is requesting approval of amendment to Commingling Order PLC-264 to Surface Commingle the oil production from the Spear Federal Well No. 1, Keel 'A' Federal Well No. 3, and Scott 'E' Federal Well No. 1.

The oil production from each well/lease will be separately metered prior to commingling. Commingling Order PLC-264 (copy attached), currently provides for the surface commingling of oil production from the North Lusk-Strawn Pool (96678), and the North Lusk-Wolfcamp Pool (41608). The requested amendment is to allow for the additional commingling of Bone Springs production (41450) with that from the pools currently authorized. The Spear #1 and the Scott E. Federal #1 have both been recompleted in the Bone Springs.

The wells will be equipped with a metering test separator for each lease, as shown in the attached process flow diagram, and in accordance with applicable provisions of the NMOCD's "Manual for the Installation and Operation of Commingling Facilities".

Attached in support of this request is a well list with locations, pool numbers, & API numbers, a table showing oil production volumes, API gravities, sulfur analyses, and monetary values for each of the wells/pools proposed for commingling, a proposed schematic diagram for the subject facility, and a lease plat. Commingling will not reduce the actual commercial value of oil or condensate sold from each pool.
