Procedure to recompleate from Wolfcamp to the 3rd Bone Spring.

Set 5 1/2" CIBP @ +/- 13185', dumpbail 35' of cement on top.

Set 2nd CIBP @ +/- 12585'.

Perforate 3rd Bone Spring from 12416' to 12435' and 12471' to 12490'.

Acidize w/ 4000 gals 7 1/2% HCl acid w/ 150 bio-ball sealers.

Turn to production test.

Work to begin ASAP.
