MIRU Casing Pulling Rig. Tag up w/2-7/8", pull 5-1/2". Replace bad joints & collars. TIH w/5-1/2". Set CIBP ± 9460' w/cmt. Pressure test to 5000 psi. Cmt 5-1/2" - circ. TIH w/2-7/8" tbg. Swab fluid level down to 5500'. TOH. Perf. 5-1/2" 5418'-5423', 5447'-5458', acdz w/2000 gals, frac w/58,000 gal & 146,000# sd. Flow to test well, run tbg, rods & pump, put well on prod.
