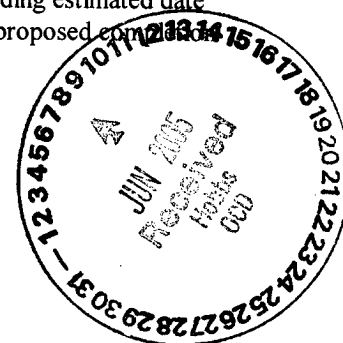

5/29/05: MI x RU. Spud 12-1/4" hole at 10:00 a.m. (NMOCD notified)

5/30/05: Run 36 jts. 8-5/8", 24#, J-55, ST&C casing with 10 centralizers and set at 1503'. RU Halliburton and cement with 450 sx. PBCZ lead and 400 sx. Premium Plus tail. Displace with 20 bbls FW x 73 bbls brine and circulate 192 sx. cement to surface. WOC 4 hours. Cut off casing x weld on wellhead. NU BOP. Test casing and blind rams to 1500 psi. Test pipe rams, annular, and choke manifold to 1500 psi. Drill out cement and resume drilling operations.
