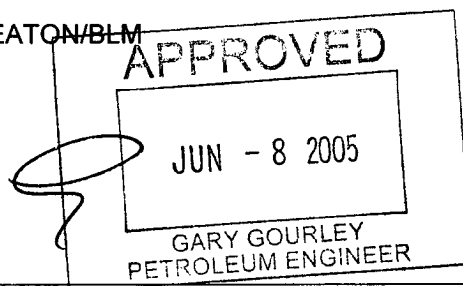

Henry Petroleum has been very active this past year (2004) returning wells to production in the unit (4 wells) and the non unit (3 wells) and is already busy doing the same this year, one on the non unit and four on the unit (approved paperwork but waiting on the rig to do the actual work). Henry would like permission to keep this well TA'd for now as we have not evaluated it for feasibility to return to production. However, this work is currently under way.

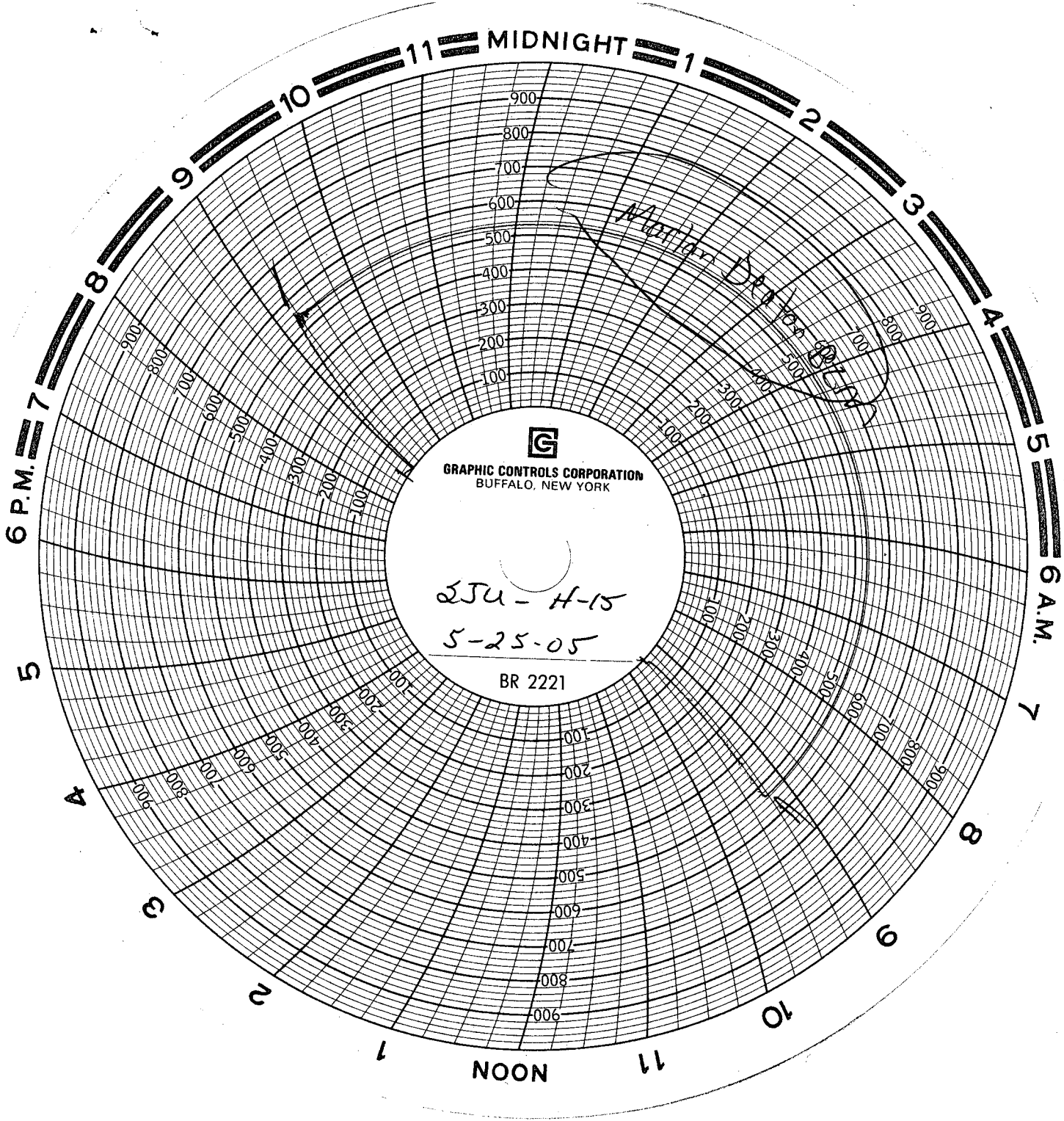
