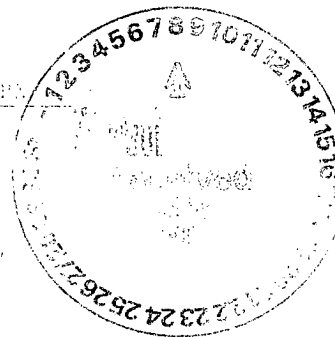

Mack Energy Corporation proposes to change the casing string on the Rainbow State #1. We are proposing to drill a 17 1/2 hole to 350', run 13 3/8 casing and cement. Drill a 12 1/4" hole to 2550', run 8 5/8 casing and cement. Drill a 7 7/8" hole to 4300', run 5 1/2" casing and cement.
