7/8/05: TD 11" hole at 3159'. Run 77 jts. 8-5/8", 24# & 32#, J-55, ST&C casing with 16 centralizers and set at 3157'. Cement with 900 sx. Interfill 'C' (lead) and 100 sx. Premium Plus (tail). Plug down x circulate 151 sx. to surface. WOC. Test casing and BOP. Drill out cement and resume drilling operations.
