COG Operating LLC respectfully requests permission to change the intermediate hole size from 12-1/4" to 11". The 11" hole will be drilled to +/- 4700'.

The BOP program will be as follows:

After setting 13-3/8" casing and installing a 3000# casing head, a 5000# double ram BOP and 3000# annular BOP will be installed and tested to 1350# with the rig pump.

After setting 8-5/8" casing and installing a 3000# casing head, a 5000# double ram BOP and 3000# annular will be installed. The double ram BOP will be tested to 3000# and the annular will be tested to 1500# with an independent tester.
