3 Knock out CIBP over Grbg/San Andres

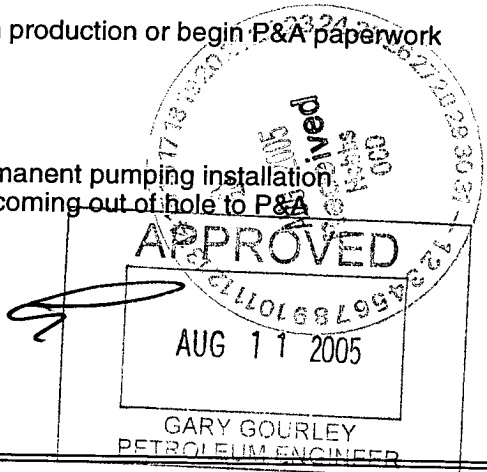
4 Istall tbg, rods & pump. Rig dwn PU

5 Tst well for 30-60 days to determine if oil production is sufficient to justify permanent pumping installation

6 If well is uneconomic, tst & evaluate potential hydrocarbon bearing zones as coming out of hole to P&A
