8/10/05: Drill to TD at 4385'. RU casing crew and run 106 jts. 5-1/2", 15.5#, J-55, LT&C casing with 10 centralizers and set at 4372'. Cement first stage with 250 sx. Premium Plus. Bump plug, open DV tool, and circulate for 4 hours. Did not circulate cement to surface. Cement second stage with 600 sx. Interfill 'C' (lead) and 100 sx. Premium Plus (tail). Plug down and circulate 30 sx. to surface. ND x set casing slips.

Release drilling rig at 8:00 a.m., 8/10/05.
