The well was recently converted to a producer (6/21/05 - 6/24/05) to complete our 5-spot pattern we are developing in the North Hobbs G/SA Unit CO2 Project. Oxy fully expects to recover EOR oil from the well as the pattern matures under CO2 injection which is scheduled to commence in the Fall of 2005. At present, the well is undergoing further post-procedure evaluation (test rates not yet available), but will eventually be turned over to production and monitored for pattern response.
