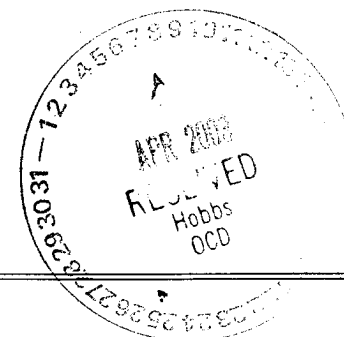

Cement 180 sx Interfill C (11.9 ppg, 2.41 ft3/sx, 13.67 GPS) and tail w/200 sx Class C Neat (14.8 ppg, 1.32 ft3/sx, 6.32 GPS). Bumped plug w/550 psi. Cement 2nd stage w/450 sx Interfill C + 5 pps gilsonite + 1/4 pps of Flocele and 200 sx Interfill C Neat (11.9 ppg, 2.41 ft3/sx, 6.32 GPS). Circulate 25 sx cement to pit. Bumped plug w/890 psi FCP and closed DV tool w/2350 psi.
