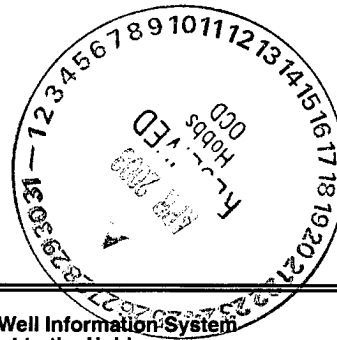

3. TIH w/Float Shoe and 2 7/8" tbg. as casing to 3,244'.
4. Cement w/500 sx Class "C" cement. Circulate to surface.
5. Perforate Langlie Mattix (Queen) formation 3100'-3150' & acidize.
6. TIH w/packer and 1 1/2" tbg. to 3050' and set packer.
