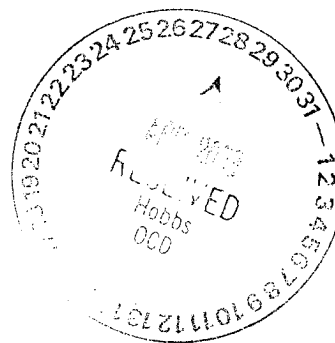

6. Spot 25 sx Class "C" @ 450'(90' cmt.).
7. Spot 5 sx Class "C" @ 50' & bring cement to surface.
8. Install dry hole marker & clean location.
