As per our conversation with Joe Lara with the Bureau of Land Management/Carlsbad Office, Edge Petroleum would like to propose an Alternate Cement and Casing Program as follows:
On the 7-5/8" casing set at 4270', we propose to set a DV Tool (Stage Collar) above an External Casing Packer (ECP). The External Casing Packer is to be set inside the 10-3/4" casing at 2950 +/- Cement will be circulated to surface.
We propose the top of cement to be at approximately 2400' for the 4-1/2" production casing.
