8-20-05 MIRT and resumed drilling. TD 17-1/2" hole to 420'. Set 13-3/8" 48# casing @ 420'. Cemented w/250 sx Premium Plus w/additives and tailed in w/200 sx. Cement circulated. WOC. Tested casing to 800#. WOC 21 hrs, 30 min. Reduced hole to 12-1/4" and resumed drilling.
