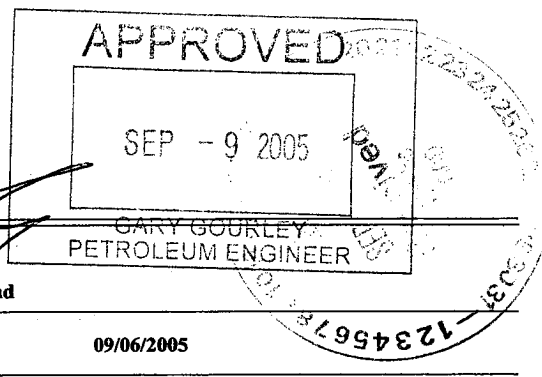

This evaluation will be completed and action taken before the expiration of the MIT.
