Stimulate perfs with 4030 gal. 15% NEFE HCL in 32 settings. RIH with Reda ESP equipment on 127 jts. 2-7/8" production tubing with drain valve (intake set at 4125'). ND BOP. Install QCI wellhead connection. NU wellhead. RDPU and clean location.
