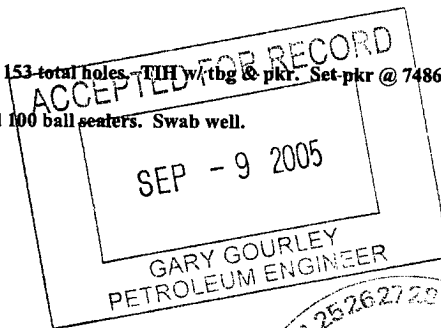

8-16-05 TIH w/ tbg & set @ 7500'. Run pump & rods. Put well on test.
