The Madera 24 Federal #2H well is connected to Southern Union Gas lines for the transport of produced gas. The Southern Union Gas plant has been having repeated problems to where the gas lines have to be shut down while the plant undergoes repairs. In this latest instance Southern Union anticipates being shut down for 10-15 days while doing repairs to the plant lines. Tommy Folsom has requested and been granted a verbal approval by Ed Fernandez of the Bureau of Land Management in Carlsbad, New Mexico to flare gas and continue producing the well. We will build a flare line and meter to monitor all flared gas volumes for the well. We estimate approximately 4,500 MCF of gas will be flared. This estimate is dependent upon the time needed for Southern Union to repair the plant problems.

5. Install gas meter on vent/flare line to measure gas prior to venting/flaring operations if it is not equipped as such at this time. Gas meter to meet all requirements for sale meter as Federal Regulations and Onshore Order #5.
