10/17/12 - 10/25/12 - PU TCP guns & tbg, pressure test csg. RIH w/ 2-7/8" tbg & perforate interval from 8,859' - 13,077' w/ 288 holes; RD WL, ND WH, NU frac tree & pressure test, okay. MIRU BHI. Fill frac tanks & prepare to frac. Frac 8 stages w/ 1,208,249# 30/50 WS, 24,978 gals 15% HCL & 779,432# 20/40 SLC. FL w/5,093 bbls slick water. RIH w/ cap plug & set @ 8,550'; install float, RU swival, break circ., drill cap plug, CHC, washing to drill plugs to PBD @ 13,080', CHC. POOH w/tbg, start flow well back.

10/29/12 - Kill well w/ 10# Brine water, pumped 60 bbls down tbg & 300 bbls down csg. POOH, L/D tbg, ND BOP stack, install WH, NU BOP stack & prep to run ESP.

10/31/12 - PU & RIH w/tbg and pump. Set btm of ESP-pump assy @ 8,530' & intake @ 8,506'; set tbg @ 8,692'. ND BOP's, NU WH & prep to start pump.

11/1/12 - Test connections & RDMO. TOP.


