Plan to drill a 17-1/2" hole to 1750' with Fresh Water. Run 13-3/8", 54.5#, J-55 csg and cmt to surface. Drill 12-1/4" hole to 5500' with Brine, and run 9-5/8", 36# J55(40# f/3500' - 5500') and cement to surface. Drill 7-7/8" hole with cut brine to 10,800'. Kick off and drill 7-7/8" curve and lateral to approx 18,919' MD. Run 5-1/2", 17#, P-110 csg and cement to 5300' in 1 stage.


