Tonto #12 Plugging Report

11-30-2011 – Move pulling unit and plugging equipment to location, rig up pulling unit and TIH to tag CIBP @ 3060', circulate plugging mud, spot 25 sacks class C cement @ 3060', TOH with tubing.

12-01-2011 - TIH with tubing to tag plug at 2730, okayed by BLM, TOH to 2450' to spot 106 sacks class C cement, TOH and WOC, TIH to tag cement @ 1299', TOH with tubing. SDFN.

12-07-2011 - Rig down BOP, NU wellhead, weld on pull nipple, TIH and cut casing off @ 1260' TOH laying down casing with lay down machine, ND wellhead, NU BOP. SDFN.

12-08-2011 – TIH with tubing to spot 45 sacks class C cement @ 1260', TOH with tubing and WOC, TIH with tubing to tag cement @ 1087', TOH to 535' to spot 40 sacks class C cement, TOH with tubing. SDFN.

12-09-2011 – TIH with tubing to tag cement @ 371', TOH with tubing to 62' to circulate 17 sacks class C cement to surface, ND BOP cut off and install marker. RDPU, move all Equipment off location.
